RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE DECEMBER 18, 2007 MIAMI BEACH HISPANIC COMMUNITY CENTER SENIOR HOLIDAY PARTY SPONSORED BY UNIDAD OF MIAMI BEACH INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$381.00 TO BE FUNDED FROM DISTRICT 5 IN-KIND RESERVE FUND

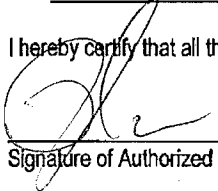

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization UNIDAD of Miami Beach, Inc. for the "Miami Beach Hispanic Community Center Senior Holiday Party" event held on December 18, 2007.

In-kind services have been requested in an amount not to exceed \$381 from the Miami-Dade Transit Agency for transportation services (1 bus). This event will be funded from District 5 in-kind reserve fund.

In FY 2007-08, UNIDAD of Miami Beach, Inc. has received \$12,570 from the General Fund.
