RECOMMENDATION

It is recommended that the Board approve the attached Resolution authorizing in-kind services for Galata, Inc., in an amount totaling \$2,103.

BACKGROUND

A retroactive waiver for in-kind services has been requested by Galata, Inc., a non-profit organization, for their annual "*Haiti in History: A Journey Through Time*" exhibition taking place throughout the month of January 2008 in the lobby of the Stephen P. Clark Center building.

In-kind services have been requested in the amount of \$503 from the Government Information Center, \$800 from the Park and Recreation Department, and \$800 from General Services Administration, for a total in-kind amount of \$2,103. The Office of Strategic Business Management has reviewed this request and recommends its approval by the Board. At the request of the Mayor, the Mayor's In-Kind Reserve Fund is being used to fund this request.



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT, THE GENERAL SERVICES ADMINISTRATION, AND THE GOVERNMENT INFORMATION CENTER FOR THE JANUARY 1-31, 2008 "A JOURNEY THROUGH TIME" EXHIBITION SPONSORED BY GALATA INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,103.00 TO BE FUNDED FROM THE MAYOR'S IN-KIND RESERVE FUND

WHEREAS, GALATA, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department, the General Services Administration, and the Government Information Center for the January 1-31, 2008 "A Journey Through Time" exhibition in an amount not to exceed \$2,103.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of "A Journey Through Time" exhibition is to promote historical and cross-cultural educational activities by commemorating Haitian independence; and

WHEREAS, the GALATA, Inc. is a not-for-profit organization; and

WHEREAS, "A Journey Through Time" exhibition is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Mayor's In-kind Reserve Fund,
