RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE DECEMBER 15, 2007 "LLAMADAS INTERNACIONALES" EVENT SPONSORED BY WEST DADE COMMUNITY SERVICES, INC. A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$569.00 TO BE FUNDED FROM THE DISTRICT 11 IN-KIND RESERVE FUND

WHEREAS, West Dade Community Services, Inc. has requested in-kind services from the Miami-Dade Transit Agency for the December 15, 2007 "Llamadas Internacionales" event in an amount not to exceed \$569.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Llamadas Internacionales" event is to provide the community an opportunity to place free long distance telephone calls in order to connect with their love ones abroad for the holidays; and



Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization West Dade Community Services, Inc. for the "Llamadas Internacionales" event held on December 15, 2007.

In-kind services have been requested in an amount not to exceed \$569 from the Miami-Dade Transit Agency for transportation services (1 bus). This event will be funded from the District 11 in-kind reserve fund.

In FY 2007-08, West Dade Community Services, Inc. has received \$173,500 from the General Fund and \$15,000 from the District 11 discretionary reserve.
