RECOMMENDATION

It is recommended that the Board approve the attached resolution awarding a contract for the MIA Central Terminal Retail Program Common Area, MDAD Project No. L-143A, to Aarya Construction & Design Inc. in the amount of \$548,273.25.

SCOPE

Miami International Airport (MIA) is located primarily within Commission District Six. However, the impact of this agenda item is countywide in nature as Miami International Airport is a regional asset.

DELEGATED AUTHORITY

The Aviation Director or designee has the authority to expend contingency accounts, extend the contract completion time to complete any unfinished work, reduce the scope of the project, and cancel or terminate the contract.

FISCAL IMPACT/FUNDING SOURCE

This project is funded by the Capital Improvements Program Retail Concessions Account.

ANNUAL OPERATION AND MAINTENANCE COSTS: (Ordinance 07-138)

Light bulb replacement.....	\$5,000
Artwork for 12 column wraps to be changed three times per year.....	\$18,000
Column Wrap replacement.....	\$6,000
Soffit paint touch up.....	\$1,000
TOTAL YEARLY COST.....	\$30,000

Funding for light bulb replacement and paint touch-up will be included in the existing terminal maintenance costs. Funding for the column wrap artwork and column wrap replacement will be included in the Commercial Operations Concession Marketing Budget.

In addition to the information contained in the CIIS database, Aarya Construction is currently working on the American Airlines Relocation Project (776-U) at MIA and their performance is satisfactory.

With respect to this project, the MDAD Project Manager, Douglas G. Jorge, will closely monitor the performance of this contractor. The contractor will be informed that they have a record of marginal performance and will be closely monitored for compliance to plans, specifications and schedules. Additional measures that may be taken by the County for poor performance include partial payments for any work that does not meet the plans and specifications and the contractor may be subject to liquidated damages for project delays.

BACKGROUND

This project is to provide an upgrade to the appearance and individual store identification in the Central Terminal. It will provide for 16 blade signs (identification signage) for the Central Terminal concessions, 12 column wraps for additional concession signage and lighting at 29 columns for the illumination of the 12 column wraps in this contract for MDAD use, plus the future 17 column wraps to be installed by tenants in the Central Terminal. The existing fascia above the stores shall also be refinished.
