MENENDEZ, D-22828, LOCATED IN THE NORTHEAST 1/4 OF SECTION 26, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 62 STREET, ON THE EAST BY FLORIDA EAST COAST RAILROAD, ON THE SOUTH BY APPROXIMATELY SW 64 STREET, AND ON THE WEST BY APPROXIMATELY SW 72 AVENUE)

WHEREAS, Manuel E. Menendez and Catherine E. Menendez, husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Northeast 1/4 of Section 26, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
