



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR TRANSPORTATION TO THE DECEMBER 16, 2007 DODGE CITY CHRISTMAS PARTY SPONSORED BY NARANJA OPTIMIST CLUB, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$852.00 TO BE FUNDED FROM THE DISTRICT 9 IN-KIND RESERVE FUND

WHEREAS, Naranja Optimist Club, Inc. has requested in-kind services from the Miami-Dade Transit Agency for transportation to the December 16, 2007 Dodge City Christmas Party in an amount not to exceed \$852.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the Naranja Optimist Club provided children with transportation to the Dodge City Christmas Party in order to allow district residents an opportunity to celebrate the holidays together; and

WHEREAS, the Naranja Optimist Club, Inc. is a not-for-profit organization; and

WHEREAS, the transportation to the Dodge City Christmas Party is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 9 In-kind Reserve Fund,



Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Naranja Optimist Club for the Dodge City Christmas Party event held on December 16, 2007.

In-kind services have been requested in an amount not to exceed \$852 from the Miami-Dade Transit Agency for transportations services (2 buses). This event will be funded from the District 9 in-kind reserve fund.

In FY 2007-08, Naranja Optimist Club has received \$12,000 from the General Fund.
