



RESOLUTION NO. 1344-07

RESOLUTION RETROACTIVELY DECLARING THE MONTH
OF JANUARY AS ADULT AND FAMILY LITERACY MONTH

WHEREAS, the need for highly literate citizens increases as Miami-Dade County moves toward an increasingly technological future; and

WHEREAS, literacy issues can have a great impact on the lives and families of adults in Miami-Dade County, and on their ability to work productively and their full participation as citizens and residents of our County; and

WHEREAS, parents create a foundation for their children's lifelong learning potential and are full partners with teachers, principals and administrators in the education of their children; and

WHEREAS, parents who improve their own literacy skills are better prepared to assist in the education of their children and are equipped with the tools and skills necessary to achieve and maintain self-sufficiency; and

WHEREAS, Miami-Dade's public schools, volunteer and community-based literacy organizations, community colleges, and libraries provide significant resources to adult basic education, literacy and family literacy services to Miami-Dade County residents; and

WHEREAS, residents of Miami-Dade County are encouraged to learn more about the importance of literacy and promote literacy in their communities,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively declares the month of January as Adult and Family Literacy Month in order to applaud the

efforts of those entities that help promote adult and family literacy services in Miami-Dade County and to encourage and further awareness of the importance of literacy in all sectors of the County's population.
