



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 25-28, 2007 CHRIST THE KING INTERNATIONAL FESTIVAL AND CARNIVAL SPONSORED BY THE ARCHDIOCESE OF MIAMI, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,166.00 TO BE FUNDED FROM THE DISTRICT 9 IN-KIND RESERVE FUND

WHEREAS, Archdiocese of Miami, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the October 25-28, 2007 Christ The King International Festival and Carnival in an amount not to exceed \$3,166.00 (see attached Fee Waiver/In-kind Service Application); and



Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization Archdiocese of Miami, Inc. for the Christ the King International Festival and Carnival held on for October 25-28, 2007.

In-kind services have been requested in an amount not to exceed \$3,166 from the Miami-Dade Park and Recreation Department for use of a large showmobile. This event will be funded from the District 9 in-kind reserve fund.

In FY 2007-08, the Archdiocese of Miami, Inc. has received \$1,000 from the District 5 County Service reserve fund.
