The following plat meets concurrency and is hereby submitted for consideration by the Board of County Commissioners for approval. The Miami-Dade County Plat Committee recommends approval and recording of the plat listed below. This plat is bounded on the north by NW 47 Street, on the east by approximately NW 25 Avenue, on the south by NW 46 Street, and on the west by approximately NW 27 Avenue.

BACKGROUND

LARGAESPADA HOMES (T-22143)

- Located in Section 22, Township 53 South, Range 41 East

PLAT RESTRICTIONS

- That the Streets, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.

- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

DEVELOPER'S OBLIGATION

- Monumentation. Bonded under bond number 7772 in the amount of \$3,300.00.



RESOLUTION APPROVING THE PLAT OF LARGAESPADA HOMES, LOCATED IN THE NORTHWEST 1/4 OF SECTION 22, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 47 STREET, ON THE EAST BY APPROXIMATELY NW 25 AVENUE, ON THE SOUTH BY NW 46 STREET, AND ON THE WEST BY APPROXIMATELY NW 27 AVENUE)

WHEREAS, Lea Largaespada, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as LARGAESPADA HOMES, the same being a replat of a portion of Lot 5 of "Wilson Estates", according to the plat thereof, as recorded in Plat Book 39, at Page 3, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 22, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
