RESOLUTION APPROVING THE WAIVER OF PLAT OF MIAMI-DADE COUNTY PARKS (SOUTHRIDGE PARK), D-22745, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 6, TOWNSHIP 56 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 194 STREET, ON THE EAST BY SW 112 AVENUE, ON THE SOUTH BY SW 196 STREET, AND ON THE WEST BY APPROXIMATELY SW 113 AVENUE)

WHEREAS, Miami-Dade County, a Political Subdivision of the State of Florida, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 53 of "Perrine Grant Subdivision", according to the plat thereof, as recorded in Plat Book 1, at Page 5, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 6, Township 56 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
