

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE GENERAL SERVICES ADMINISTRATION DEPARTMENT AND THE MIAMI-DADE POLICE DEPARTMENT FOR THE FEBRUARY 24, 2008 11TH ANNUAL MIAMI HEAT FAMILY FESTIVAL SPONSORED BY DADE COMMUNITY FOUNDATION, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$10,800.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

WHEREAS, Dade Community Foundation has requested in-kind services from the General Services Administration Department and the Miami-Dade Police Department for the February 24, 2008 11th Annual Miami Heat Family Festival in an amount not to exceed \$10,800.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the 11th Annual Miami Heat Family Festival is to allow Miami Heat players, coaches, celebrities and 250 families to come together for a day to raise significant funds for the Miami Heat Charitable Fund which, in turn, supports programs for the betterment of at-risk families in South Florida; and

WHEREAS, the 11th Annual Miami Heat Family Festival is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

Dear Applicant:

This modifies our letter of the above date in which we stated that you would be treated as an organization that is not a private foundation until the expiration of your advance ruling period.

Your exempt status under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3) is still in effect. Based on the information you submitted, we have determined that you are not a private foundation within the meaning of section 509(a) of the Code because you are an organization of the type described in section 509(a)(1) and 170(b)(1)(A)(vi).



However, if you lose your section 509(a)(1) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(1) organization.

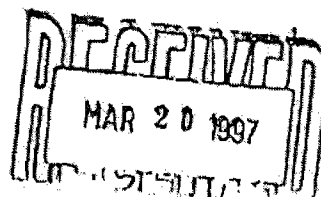

Subject: Countywide In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization the Dade Community Foundation, Inc. for the Miami Heat Charitable Fund event held on February 24, 2008.

In-kind services have been requested in an amount not to exceed \$7,500 from the General Services Administration Department for use of Parcel "B" located at 601 Biscayne Boulevard, \$3,300 from the Miami-Dade Police Department for personnel services for a total in-kind amount of \$10,800. This event will be funded from the countywide in-kind reserve fund.

In FY 2007-08, the Dade Community Foundation, Inc. has received \$245,000 from the General Fund and \$10,000 from the District 8 discretionary reserve.
