





Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A fee waiver for in-kind services has been requested by a not-for-profit organization the Whispering Pines Woman's Club, Inc. for the 41st Annual Fourth of July Celebration scheduled for July 4, 2008.

In-kind services have been requested in an amount not to exceed \$926 from the Miami-Dade Park and Recreation Department for use of a small showmobile. This event will be funded from the District 8 in-kind reserve fund.

In FY 2007-08, Whispering Pines Woman's Club, Inc. has received no County funding for this event.
