RECOMMENDATION

The following plat meets concurrency and is hereby submitted for consideration by the Board of County Commissioners for approval. The Miami-Dade County Plat Committee recommends approval and recording of the plat listed below. This plat is bounded on the north by SW 30 Street, on the east by SW 144 Avenue, on the south by approximately SW 31 Street, and on the west by approximately SW 144 Place.

BACKGROUND

BAROQUE ESTATES (T-22462)

- Located in Section 15, Township 54 South, Range 39 East
- Commission District: 11
- Zoning: RU-1
- Proposed Usage: Single family residences
- Number of parcels: 6

PLAT RESTRICTIONS

- That the Avenue and Street, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.

- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That areas adjacent to the canal are to be graded to prevent overland storm water runoff into the canal.
- That the utility easement at the sides, front and rear of certain lots, depicted by dashed lines on the plat, is hereby reserved for the installation and maintenance of public utilities.

DEVELOPER'S OBLIGATION

- Paving, street name signs, drainage, guardrail, traffic control signs, striping and monumentation. Bonded under bond number 7785 in the amount of \$44,090.00.

RESOLUTION APPROVING THE PLAT OF BAROQUE ESTATES, LOCATED IN THE NORTHWEST 1/4 OF SECTION 15, TOWNSHIP 54 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 30 STREET, ON THE EAST BY SW 144 AVENUE, ON THE SOUTH BY APPROXIMATE SW 31 STREET, AND ON THE WEST BY APPROXIMATE SW 144 PLACE)

WHEREAS, Baroque Developers, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as BAROQUE ESTATES, the same being a replat of a portion of Tract 5A of the plat of J.G. Head's Farms, according to the plat thereof, as recorded in Plat Book 46, at Page 44 of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 15, Township 54 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
