**081537 Ordinance**

ORDINANCE RELATING TO CHAPTER 26 OF THE CODE OF MIAMI-DADE COUNTY ENTITLED "PARK AND RECREATION DEPARTMENT RULES AND REGULATIONS"; AMENDING SECTION 26-1, RULE 33 FOR THE PURPOSE OF AUTHORIZING THE PARK AND RECREATION DEPARTMENT DIRECTOR TO PERMIT THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES AT ADULT ATHLETIC EVENTS HELD IN COUNTY PARKS AND RECREATIONAL FACILITIES; PROVIDING SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE (Park & Recreation Department)

**Report:** *Assistant County Attorney Ferrer read the foregoing proposed ordinance into the record.*

*The public hearing was opened; however it was closed after no one appeared in response to Chairman Souto's call for persons wishing to be heard in connection with the foregoing proposed resolution.*

*Mr. Jack Kardys, Director, Park & Recreation Department (MDPR), explained the intent of the foregoing proposed ordinance. He noted that the ordinance gave MDPR the ability to issue permits to serve alcoholic beverages in specific County-owned and operated park facilities during sports events sponsored for adults. Mr. Kardys pointed out that this would be completely controlled by requiring off-duty police officers and other proper security mechanisms and by requiring appropriate licensing.*

*In response to Chairman Souto's inquiry regarding the types of alcoholic beverages to be sold, Mr. Kardys explained that this ordinance allowed any type of alcoholic beverage to be sold, particularly beer and wine. He noted that at large sporting events, beer and wine would be sold and at smaller more controlled events, other types of alcoholic beverages would be sold.*

*Concerning questions raised by Commissioner Rolle regarding the reference to "other suitable facilities throughout the park system and how the Director defined adequate security., Mr. Kardys explained that both off-duty police officers and park security officers would be used to patrol and control significant, spectator events; that the State of Florida governs the sale of alcoholic beverages*

*in stadiums and other facilities located within a contained area like an equestrian center where gates and other security controls were in place. He clarified that this type of permit would be limited and only issued for events aimed at attracting adults. Mr. Kardys also noted public safety would be paramount when issuing such permits and that he—in consultation with the Miami-Dade Police Department—would determine the number of security personnel needed for each event. He explained that permit(s) would be issued by his office and signed by him in conjunction with Miami-Dade Police Department.*

*Pointing out that selling alcohol in parks could result in problems, Commissioner Rolle asked Mr. Kardys to provide an example of an event in a park where children would be prohibited.*

*Mr. Kardys clarified that he was not suggesting that children would not be allowed; that the sale of alcohol would not be permitted during any youth event; that it would be limited to adult spectator sports event. Using Soccer as an example, he noted a family may bring children to a game, but beer would only be sold to an adult with appropriate identification to show proof of age. Additionally, Mr. Kardys noted the sale of beer would be prohibited at soccer games after half time.*

*Referring to the County Manager's recommendation which states that the event promoters and vendors would cover all liability at these types of events, Commissioner Edmonson questioned who would be liable if someone falls over a trash bin and other park equipment. Mr. Kardys explained that the promoter would be liable; that this type of liability would be covered through a liability insurance policy provided by the promoter's insurance company.*

*Commissioner Edmonson questioned whether this meant that the County could not be sued for any type of accident.*

*Mr. Kardys said he would have to defer to the County Attorney.*

*Assistant County Attorney Ferrer noted that obviously the County could be sued, but the County would be protected through the agreement with the promoters and the vendors.*

*Commissioner Edmonson questioned why this was not under the Mayor's discretion versus the Department Director's discretion.*

*Assistant County Attorney Munoz noted it could be under the Mayor's or the Director's discretion; that the reason it was under the Director's discretion was because the department dealt with a lot of special events and they would be negotiating directly with the promoters/vendors. Additionally, he noted the department would consider and approve on a case-by-case basis, determine the amount of security for each event, and check the insurance requirements.*

*Mr. Kardys explained that the Administrative Order to special events places the authority of special event signature under the Director for regular, general special events; that only those permits that involve events on private property required that County Manager's signature.*

*Commissioner Edmonson questioned the criteria that would be used to determine who could and could not sell alcoholic beverages during events.*

*Mr. Kardys said large adult sporting events held at venues such as the Crandon Park Tennis Center (which was designed specifically for emissions, with gating system(s) to control ingress/egress, and with concession stands) would be an ideal venue to sell alcoholic beverages. He explained that the department would work with Miami-Dade Police to ensure it was an appropriate venue.*

*Commissioner Sorenson spoke in support of this ordinance, noting she felt it was reasonable and would generate revenues for parks.*

*Commissioner Jordan noted, for the record, that this proposed ordinance was not unique in terms of other parks across the country.*

*Mr. Kardys said he did not believe so; that it was not unique in terms of events held at stadiums. He noted all special events such as rib fests and other large events held throughout parks were already permitted for the sale of alcoholic beverages or beer and wine through a not-for-profit permit. He explained that this ordinance would not result in a significant expansion in the number of activities.*

*Commissioner Moss questioned whether any of the venues tied into soccer related events. Mr. Kardys noted soccer, chess, and equestrian were the three*

primary areas targeted for expansion. He concurred with Commissioner Moss that the thinking was to allow the sale of alcoholic beverages during professional and/or semi-professionals soccer events. He noted the Sports Commission was developing a new soccer series and he felt it was important to be prepared in anticipation of an influx of more spectator sports over the coming years. Mr. Kardys pointed out that without these types of accommodations, the promoters may go to the City of Miami or some other alternative facilities rather than using the County's facilities.

Chairman Souto expressed concerns regarding the sale of alcoholic beverages at sporting events. He asked Mr. Kardys to closely monitor the sale of alcoholic beverages in parks during events and to provide a monthly progress report to the committee. Chairman Souto recommended the foregoing proposed ordinance include a one-year sunset provision.

There being no further discussion, the committee members voted to forward the foregoing proposed ordinance to the County Commission with the amendments noted by Chairman Souto.

ORAL REPORT RE: UPDATE ON PARK AND RECREATION DEPARTMENT'S ADOPT-A-PARK AND CORPORATE SPONSORSHIP PROGRAMS (County Manager)

**Report:** *Assistant County Attorney Ferrer read the foregoing proposed report into the record.*

*Mr. Jack Kardys, Director, Miami Dade Park & Recreation (MDPR) provided a brief introduction regarding the Adopt-A-Park program and The Park Foundation. He noted the Park Foundation was created as an advocate organization for the 2004 Building Better Communities Bond issue and an operating agreement between MDPR and the Park Foundation began in June 2004.*

*Mr. George Lopez, President, Park Foundation, noted the Foundation served as a support mechanism to MDPR. He said over the last several years the Foundation raised money, served as a vehicle for activities throughout the County, and served as a voice behind the scenes for MDPR. Mr. Lopez noted the Foundation was excited about launching its Website and revenue generating opportunities. He pointed out that membership was important to the Foundation and suggested that MDPR launch a countywide or statewide membership program where people could contribute, participate, and adopt parks to generate additional revenues. Mr. Lopez said he was honored to be a part of MDPR's team.*

*Mr. Kardys said the Park Foundation had nearly \$200,000 in its account and had assisted in raising \$50,000 towards the Great Park Summit. He noted staff was seeking to put \$100,000 of the \$200,000 in an endowment with the Dade Community Foundation. Mr. Kardys introduced Ms. Allison Diego, Assistant Director, MDPR, who presented a Power Point presentation regarding the Adopt-A-Park Program.*

*Ms. Diego pointed out that the Adopt-A-Park Program proved successful in raising funds during the first few years and that a total of \$1 million dollars had been raised thus far. She said the first phase of the Adopt-A-Park online program was being implemented which included Adopt-A-Bench, Adopt-A-Tree, volunteer opportunities,*

*Adopt-A-Dog Park and Adopt-A-Program (scholarship program, leisure access equipment and programming, and educational opportunities). Ms. Diego noted this online program would promote "green giving" to help beautify and enhance parks; that the entities that had made a difference within the park system included: Community Based Organizations (CBO's), non-profit organizations, civic and church groups, schools, scout troops, families and individuals. She provided an overview of recent Adopt-A-Park Events and a brief description of the website which she noted was currently live.*

*In response to Commissioner Moss' inquiry whether the \$1 million collected were contributions, Ms. Diego responded that it was 45% cash and 55% in-kind contributions.*

*Commissioner Moss asked Mr. Kardys to consider using dedicated funding sources to sustain parks in the future.*

*Commissioner Sorenson noted that this was a great program and suggested that all commissioners add a link to this site on their own commission website. She also noted that in New York City's Central Park every bench had a metal plaque engraved with the family, person or corporation that contributed to the park.*

**Report:** *Mr. Rick Arriola, Chairman, Performing Arts Center Trust, gave a brief report regarding the Adrienne Arsht Performing Arts Center (PAC). He reported that ticket sales through April 2008 were 26% higher, noting that The Very Hungry Caterpillar, La Boheme and the Master Chorale were just a few of the sold out performances at the PAC. Mr. Arriola stated that through April the occupancy costs for the year was \$1 million less than budget and the current projections continued to reflect a balanced budget. He noted new members of the PAC Trust Board included State of Florida Representative Dan Gelber, Attorney Alan Fein, Sergio Gonzalez of University of Miami, Adriana Savino of the City of Key Biscayne, Gilbert Cabrerra of the City of Miami, Attorney Richard Milstein, and Realty Developer Scott Robbins. Mr. Arriola also noted Ms Carolyn Taylor, City of Miami and City of Miami Beach Mayor Mattie Bower were reappointed to the Trust Board.*

*Mr. Arriola noted the following upcoming performances at the PAC: Go Diego Go, Celia: The life and music of Celia Cruz, Miami Libre, Slava's Snow Show, Summer Shorts, Myriam Hernandez, Commissioner Joe A. Martinez' Annual Art Exhibition, Creative Golden Vision's Senior Exhibition and the International Hispanic Theater Festival. He also noted that the Free Gospel Sundays Series continued, featuring local Gospel Choirs.*

*Commissioner Moss commended Mr. Arriola and staff for changing the financial situation at the PAC. He suggested that the PAC staff explore bringing the Broadway production of The Lion King to the PAC.*

*Commissioner Sorenson concurred with Commissioner Moss' comments.*

**Report:** *Mr. Jack Kardys, Director, Park & Recreation Department, provided an oral report regarding the upcoming Miami International Agritech & Livestock Expo. He noted that the show was only a few days away and that 230 head of cattle were scheduled to participate in the show. Mr. Kardys noted that on Friday (5/16) morning the education session would begin at the Blue Room at Tamiami and approximately 50 people were signed up for this session. He pointed out that the sessions were provided by the University of Florida staff and discussions would revolve around USDA sanitary requirements, creating economic opportunity for the US agricultural industry, good agricultural practices on farms, and nutritional management considerations for Brahmin influenced heifers. Mr. Kardys said a press conference was scheduled for Friday (5/16) at 11 a.m. and Congressman Lincoln Diaz-Balart, Commissioner of Agriculture Charles Bronson as well as Commissioner Souto would be in attendance. On Saturday (5/17) the spectator activities would begin as well as the judging of the cattle noted Mr. Kardys. He said Brangus breed cattle judging would begin at 9 a.m., the pig races would begin at 10 a.m., 12:30 p.m., 3 p.m. and 5:30 p.m.; and other spectator activities throughout the weekend included: rodeo roping demonstration, Miami Dog obedience demonstration, cattle chip toss contest, the Brahman Breed Cattle judging, Simmental Breed Cattle judging, and live bands.*

*Chairman Souto expressed appreciation to Mr. Kardys and his supporting staff for working diligently at developing the Livestock Expo.*

**Report:** *Mr. Kenneth Newman, 2350 Arch Creek Drive, North Miami appeared before the committee. He noted that Summer school had been cancelled with the exception of a few hundred seniors that needed Summer school to graduate. Mr. Newman pointed out that since schools would be closed, the schools' playgrounds would be closed and inaccessible to children. Mr. Newman said this presented a problem for every municipality and he expressed concern that juvenile delinquency would increase because of the inaccessibility to the schools' playgrounds. He requested that this problem be resolved if possible.*

*Mr. Newman apprised committee members that the Miami Dade Soccer Complex was not funded and suggested a funding source be identified for this complex.*

*Mr. Newman said in the coming weeks the County Commission would encounter an agreement concerning the City of North Miami and Biscayne Landings. He noted that the residents of North Miami were concerned and had asked Biscayne Landings representatives to negotiate for additional park property to the City of North Miami. He noted concerns were expressed regarding these negotiations and he urged the Commission to examine this situation.*

*Assistant County Manager Munoz noted that all county summer programs were opened. He stated that he would meet with Dade County School Board representatives within the week to discuss whether school playgrounds could be opened during the Summer.*
