The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization the Haitian American Historical Society, Inc. for the Haitian American Parade event held on May 3, 2008.

In-kind services have been requested in an amount not to exceed \$2,482 from the Miami-Dade Park and Recreation Department for the use of a show mobile and two sets of bleachers. This event will be funded from the District 3 in-kind reserve fund.

In FY 2007-08, the Haitian American Historical Society, Inc. has received \$1,000 from District 3 discretionary reserve.
