

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE APRIL 18, 2008 "GOULDS MARCH AGAINST CRIME" SPONSORED BY GREATER GOULDS OPTIMIST CLUB INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$396.00 TO BE FUNDED FROM THE DISTRICT 9 IN-KIND RESERVE FUND

**WHEREAS**, Greater Goulds Optimist Club, Inc. has requested in-kind services from the Miami-Dade Transit Agency for the April 18, 2008 "Goulds March Against Crime" event in an amount not to exceed \$396.00 (see attached Fee Waiver/In-kind Service Application); and

## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization the Greater Goulds Optimist Club, Inc. for the Goulds March Against Crime event held on April 18, 2008.

In-kind services have been requested in an amount not to exceed \$396 from the Miami-Dade Transit Agency for shuttle transportation services. This event will be funded from the District 9 in-kind reserve fund.

In FY 2007-08, Greater Goulds Optimist Club, Inc. has received \$122,250 from the General Fund and \$10,000 from District 9 discretionary reserve.
