

RESOLUTION APPROVING THE STATE ROAD DESIGNATION OF S.W. 27TH AVENUE FROM FLAGLER STREET TO S.W. 5TH STREET AS "RAQUEL REGALADO AVENUE"

**WHEREAS**, during the 2008 regular session, the Florida Legislature passed Senate Bill 1604, which, among other road designations, designated S.W. 27th Avenue from Flagler Street to S.W. 5th Street as "Raquel Regalado Avenue"; and

**WHEREAS**, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

**WHEREAS**, before the Florida Department of Transportation will install signs reflecting the "Raquel Regalado Avenue" road designation, Miami-Dade County is required to pass a resolution in support of this road designation,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board approves the State Road designation of S.W. 27th Avenue from Flagler Street to S.W. 5th Street as "Raquel Regalado Avenue."
