

RESOLUTION DIRECTING THE COUNTY MAYOR OR HIS DESIGNEE TO PLACE FOR COMPETITIVE BID THE OPERATION OF ANY BUS ROUTE TO BE ELIMINATED BY MIAMI-DADE TRANSIT OR ANY BUS ROUTE THAT HAS BEEN ELIMINATED BY MIAMI-DADE TRANSIT WITHIN THE PAST YEAR

WHEREAS, budgetary restraints have forced Miami-Dade Transit to reduce and/or eliminate certain bus routes; and

WHEREAS, the further elimination of bus routes will likely cause inconvenience and hardship to thousands of Miami-Dade County residents and visitors; and

WHEREAS, there may be interest on the part of the private sector to operate some or all of the routes already or potentially eliminated,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor to place for competitive bid the operation of any bus route to be eliminated by Miami-Dade Transit or any bus route that has been eliminated by Miami-Dade Transit within the past year.
