

RESOLUTION WAIVING THE RESIDENCY  
REQUIREMENTS AND THE PROHIBITION OF SERVING ON  
MORE THAN TWO COUNTY BOARDS OF SECTION 2-11.38  
OF THE CODE OF MIAMI-DADE COUNTY FOR DOMESTIC  
VIOLENCE OVERSIGHT BOARD MEMBER APPOINTEE  
RONALD BOOK

**WHEREAS**, Ronald Book maintains significant alliance to Miami-Dade County; and

**WHEREAS**, Ronald Book's dedication, service and professional experience has significantly contributed to this County; and

**WHEREAS**, each Commissioner of the Board of County Commissioners is required to appoint one member to the Domestic Violence Oversight Board; and

**WHEREAS**, Ronald Book has been appointed by Commissioner Carlos A. Gimenez; and

**WHEREAS**, Section 2-11.38 of the Miami-Dade County Code requires that all members of County boards be permanent residents of Miami-Dade County; and

**WHEREAS**, Ronald Book is not a permanent resident of Miami-Dade County; and

**WHEREAS**, pursuant to 2-11.38 of the Miami-Dade County Code, the Board of County Commissioners is authorized by a two-thirds (2/3) vote of its membership to waive this residency requirement; and

**WHEREAS**, Section 2-11.38 of the Miami-Dade County Code prohibits an individual to simultaneously serve on more than two (2) County boards; and

**WHEREAS**, Ronald Book currently serves on the Miami-Dade County Homeless Trust Board and the Miami-Dade Community Affordable Housing Strategies Alliance (“CAHSA”); and

**WHEREAS**, pursuant to 2-11.38 of the Miami-Dade County Code, the Board of County Commissioners, after it is advised of all of the other County boards that Ronald Book serves on, may by a unanimous vote waive this prohibition and allow him to serve on a third County board,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board, pursuant to Section 2-11.38 of the Code of Miami-Dade County, waives the residency requirement and the prohibition against sitting on more than two (2) County boards, thereby authorizing Ronald Book to fulfill his appointment as a member of the Domestic Violence Oversight Board.

The Prime Sponsor of the foregoing resolution is Commissioner Carlos A. Gimenez. It was offered by Commissioner \_\_\_\_\_, who moved its adoption. The motion was seconded by Commissioner \_\_\_\_\_ and upon being put to a vote, the vote was as follows:
