RESOLUTION APPROVING THE WAIVER OF PLAT OF HECHT BIRD ROAD PROPERTY, LTD., D-22900, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 15, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 38 STREET, ON THE EAST BY APPROXIMATE SW 84 AVENUE, ON THE SOUTH BY SW 40 STREET AND ON THE WEST BY SW 87 AVENUE)

WHEREAS, Hecht Bird Road Property, Ltd., a Florida limited partnership, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of the Southwest 1/4 of Section 15, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


