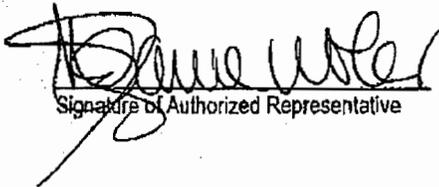

Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the American Cancer Society, Florida Division for their Relay For Life of Key Biscayne event held on March 1, 2008.

In-kind services have been requested in an amount not to exceed \$866 from the Miami-Dade Park and Recreation Department for the use of one (1) show mobile. This event will be funded from the District 7 in-kind reserve fund.

In FY 2007-08, the American Cancer Society has received \$48,255 from the following discretionary reserve funds: \$7,755 from District 1, \$5,000 from District 3, \$500 from District 6, \$5,000 from District 7, \$5,000 from District 8, \$5,000 from District 9, \$15,000 from District 10, \$2,500 from District 11, and \$2,500 from District 12. In addition, the American Cancer Society has received in-kind services for the following Relay for Life events: \$1,542 for Northwest Dade (R 546-08) and \$866 for East Kendall (R 270-08).
