RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND THE MIAMI DADE FIRE RESCUE DEPARTMENT FOR THE AUGUST 6, 2008 "RICK ROSS BE OUT DAY" EVENT SPONSORED BY RICK ROSS CHARITES, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,456.00 TO BE FUNDED IN PART FROM THE DISTRICT 1 IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE IN-KIND RESERVE FUND

WHEREAS, Rick Ross Charities, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department and Miami-Dade Fire Rescue Department for the August 6, 2008 "Rick Ross Be Out Day" event in an amount not to exceed \$1,456.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Rick Ross Be Out Day" event is to assist families with children who are returning to school by providing free backpacks, school supplies and health screening; and

WHEREAS, Rick Ross Charities, Inc. is a not-for-profit organization; and

WHEREAS, the "Rick Ross Be Out Day" event is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$791.00 of the in-kind services shall be funded from the District 1 In-kind Reserve Fund, and \$665.00 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund,

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Rick Ross Charities, Inc. for the "2nd Annual Rick Ross Be Out Day" for event held on August 6, 2008.

In-kind services have been requested in an amount not to exceed \$791 from the Miami-Dade Park and Recreation Department for the use of a large show mobile and \$665 from the Miami-Dade Fire Rescue Department for personnel services for a total in-kind amount of \$1,456. This event will be funded in part from the District 1 in-kind reserve fund and in part from the non-ad valorem in-kind reserve of the fire rescue district in-kind reserve.

In FY 2007-08, Rick Ross Charities, Inc. has received no county funding for this event.
