A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$776.00 TO BE FUNDED FROM THE DISTRICT 11 IN-KIND RESERVE FUND







Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Miami Baptist Church for the "Harvest Festival" held on October 31, 2007.

In-kind services have been requested in an amount not to exceed \$776 from the Miami-Dade Park and Recreation Department for use of a 24 x 40 stage. This event will be funded from the District 11 in-kind reserve fund.

In FY 2007-08, the Miami Baptist Church has received no County funding for this event.
