

RESOLUTION DIRECTING THE MAYOR TO EXPLORE USE
OF HIGH FREQUENCY PLASMA ELECTRODELESS
INDUCTION LAMPS IN COUNTY BUILDINGS AND
FACILITIES

WHEREAS, induction lamps may provide illumination at less than half the electrical energy of conventional HID (Mercury Vapor, Metal Halide, High Pressure Sodium) lamps, slash CO₂ emissions to less than half, and last five times longer; and

WHEREAS, induction lamps may, in comparison with other illumination technologies: have a zero re-start time (hot or cold); use only a fraction of Mercury; produce more lumen (light); have no ballast (which draws a lot of energy, drag power factor, and fail); have no end caps (which often induces failures); have no pins (which hinder a good contact and often cause failures); and illuminate flicker-free; and

WHEREAS, the utilization of induction lamps in County buildings and facilities may provide significant savings to the County and reduce CO₂ emissions,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Mayor is hereby directed to explore the use of high frequency plasma electrodeless induction lamps in County buildings and facilities and to report to the Board of County Commissioners on the feasibility, financial and otherwise, of such use not later than sixty (60) days after passage of this Resolution.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
