RESOLUTION APPROVING THE WAIVER OF PLAT OF MIAMI-DADE COUNTY-GSA, D-22911, LOCATED IN THE NORTH 1/2 OF SECTION 25, TOWNSHIP 55 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 152 STREET, ON THE EAST BY APPROXIMATELY SW 119 AVENUE, ON THE SOUTH BY APPROXIMATELY SW 156 STREET, AND ON THE WEST BY SW 124 AVENUE)

WHEREAS, Miami-Dade County-GSA, a political subdivision of the State of Florida, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the North 1/2 of Section 25, Township 55 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


