

RESOLUTION CHANGING THE NAME OF THE MIAMI-
DADE POLICE DEPARTMENT CUTLER RIDGE DISTRICT
STATION TO THE SOUTH DISTRICT STATION

WHEREAS, the Town of Cutler Bay incorporated in 2005; and

WHEREAS, the Miami-Dade Police Department Cutler Ridge District Station is located at 10800 SW 211th Street in what is now the Town of Cutler Bay; and

WHEREAS, the area served by the Cutler Ridge District Station extends well beyond the boundaries of the Town of Cutler Bay; and

WHEREAS, the Cutler Ridge District Station is responsible for the unincorporated area of Miami-Dade County as well as County-owned or maintained facilities located south of S.W. 200th Street west of U.S. 1, and south of Coral Reef Drive/S.W. 152nd Street from the Florida Turnpike Extension east to Biscayne Bay; and

WHEREAS, changing the name of the Cutler Ridge District Station to the South District Station will ensure that there is no confusion between the Cutler Ridge District Station and the Town of Cutler Bay for important police services; and

WHEREAS, this facility renaming is located in County Commission District 8,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Renames the Miami-Dade Police Department “Cutler Ridge District Station” the “South District Station.”

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, and the following departments of Miami-Dade County: Police, Fire-Rescue, General Services Administration, and Public Works.
