

RESOLUTION JOINING THE MIAMI CITY COMMISSION IN
CODESIGNATING S. MIAMI AVENUE FROM ALATKA
STREET TO U.S. 1 AS THE "MOST REVEREND AGUSTÍN A.
ROMÁN WAY"

WHEREAS, Bishop Agustín A. Román came to South Florida after being expelled from Cuba, along with 132 other Cuban priests, by the communist regime; and

WHEREAS, Bishop Román raised funds for the construction of the *Shrine of Our Lady of Charity* on Biscayne Bay, where he still works as director as the beacon for exiles from many nations; and

WHEREAS, on September 25, 2008, the City Commission for the City of Miami adopted Resolution No. 08-0541, a copy of which is attached and incorporated by reference, which urged Miami-Dade County to codesignate S. Miami Avenue from Alarka Street to U.S. 1, Miami, Florida, as the "Most Reverend Agustín A. Román Way"; and

WHEREAS, this road codesignation is located in County Commission District 7,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Finds that Bishop Agustín A. Román has made a direct significant lifetime contribution to this community.

Section 2. By a three-fifths vote of the Board members present, joins the Miami City Commission in codesignating S. Miami Avenue from Alarka Street to U.S. 1 as the "Most Reverend Agustín A. Román Way."

Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Miami City Commission, the United States Postal Service, the Traffic Signals

and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Carlos A. Gimenez. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

A RESOLUTION OF THE MIAMI CITY COMMISSION, WITH ATTACHMENT(S), URGING MIAMI-DADE COUNTY TO CODESIGNATE SOUTH MIAMI AVENUE FROM ALATKA STREET NORTH TO U.S. 1, MIAMI, FLORIDA, AS THE "MOST REVEREND AGUSTÍN A. ROMÁN WAY;" FURTHER DIRECTING THE CITY MANAGER TO INSTRUCT THE DIRECTOR OF PUBLIC WORKS TO WORK WITH MIAMI-DADE COUNTY AND ANY OTHER AGENCIES TO ENSURE THAT ALL CO-DESIGNATION PROCEDURES ARE COMPLETED BEFORE THE END OF CALENDAR YEAR 2008, IN ANTICIPATION OF A CEREMONY DEDICATING "THE MOST REVEREND AGUSTÍN A. ROMÁN WAY " TO MARK THE RETIRED AUXILIARY BISHOP OF MIAMI'S 50TH YEAR IN THE PRIESTHOOD; FURTHER DIRECTING THE TRANSMITTAL OF A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICES.

WHEREAS, this Resolution directs the City Manager to instruct the Public Works Department to work with Miami-Dade County and any other agencies to ensure that all co-designation procedures are completed before the end of calendar year 2008, in anticipation of a ceremony dedicating "The Most Reverend Agustín A. Román Way," to mark the retired auxiliary bishop of Miami's 50th year in the priesthood; and

WHEREAS, Bishop Román came to South Florida after being expelled, along with 132 other Cuban priests, from Cuba by the communist regime; and

WHEREAS, Bishop Román raised funds for the construction of the *Shrine of Our Lady of Charity* on Biscayne Bay, where he still works as director as the beacon for exiles from many nations; and

WHEREAS, Bishop Román's resume is attached, in keeping with the City Commission's recent vote to allow street co-designations for living people of extremely high character and civic contribution;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

Section 2. The Miami City Commission urges Miami-Dade County to codesignate South Miami Avenue from Alatka Street North to U.S. 1, Miami, Florida, as "The Most Reverend Agustín A. Román Way."

Section 3. The City Manager is directed to instruct the Public Works Department to work with Miami-Dade County and any other agencies to ensure that all co-designation procedures are completed before the end of calendar year 2008, in anticipation of a ceremony dedicating "The Most Reverend Agustín Román Way," to mark the retired auxiliary bishop of Miami's 50th year in the

priesthood and to transmit a copy of this Resolution to the City's Departments of Police, Fire-Rescue, Solid Waste, and also to the Miami-Dade County Public Works Department and the United States Postal Service.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.{1}
