RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 11, 2008 "HISPANIC HERITAGE NIGHT" SPONSORED BY THE GLADEVIEW BAPTIST CHURCH OF MIAMI, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,737.00 TO BE FUNDED FROM THE DISTRICT 11 IN-KIND RESERVE FUND

Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Gladeview Baptist Church of Miami, Inc. for their "Hispanic Heritage Night" scheduled for October 11, 2008.

In-kind services have been requested in an amount not to exceed \$4,737 from the Miami-Dade Park and Recreation Department for use of one (1) show mobile, bleachers, tower lights and a sound system. This event will be funded from the District 11 in-kind reserve fund.

In FY 2008-09, the Gladeview Baptist Church of Miami, Inc. has received no county funding for this event.
