RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE NOVEMBER 2, 2008 "BETH TORAH COMMUNITY EVENT" SPONSORED BY THE BETH TORAH ADATH YESHURUN, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,940.00 TO BE FUNDED IN PART FROM THE DISTRICT 4 IN-KIND RESERVE FUND AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT BUDGET

WHEREAS, the Beth Torah Adath Yeshurun, Inc. has requested in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the November 2, 2008 "Beth Torah Community Event" in an amount not to exceed \$4,940.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Beth Torah Community Event" is a communitywide event featuring, among other things, a carnival; and

WHEREAS, the Beth Torah Adath Yeshurun, Inc. is a not-for-profit organization; and

WHEREAS, the "Beth Torah Community Event" is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$4,560.00 of the in-kind services shall be funded from the District 4 In-kind Reserve Fund and \$380.00 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District Budget,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the November 2, 2008 "Beth Torah Community Event" in an amount not

to exceed \$4,940.00 to be funded in part from the District 4 In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue District Budget.

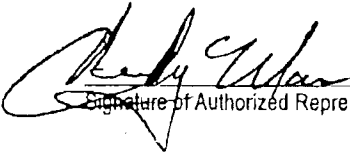

Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Beth Torah Adath Yeshurun, Inc. for their "Beth Torah 60th Anniversary Kickoff Event" held on November 2, 2008.

In-kind services have been requested in an amount not to exceed \$4,560 from the Miami-Dade Police Department for police services and \$380 from the Miami-Dade Fire Rescue Department for fire rescue personnel and emergency medical services for a total in-kind amount of \$4,940. This event will be funded in part from the District 4 in-kind reserve fund and in part from the non-ad valorem portion of the Fire Rescue District Budget.

In FY 2008-09, Beth Torah Adath Yeshurun, Inc. has received no county funding for this event.
