

RESOLUTION APPROVING THE CO-DESIGNATION OF  
CODADAD STREET FROM JANN AVENUE TO ALI-BABA  
AVENUE IN THE CITY OF OPA-LOCKA AS "THE  
HONORABLE BRIAN HOOTEN STREET"

**WHEREAS**, on October 8, 2008, the City Council of the City of Opa-locka adopted Ordinance No. 08-17, which designated Codadad Street from Jann Avenue to Ali-Baba Avenue as "The Honorable Brian Hooten Street" in recognition of his contributions to the City, a copy of which is attached and incorporated by reference; and

**WHEREAS**, Codadad Street from Jann Avenue to Ali-Baba Avenue is a city road located in the City of Opa-locka; and

**WHEREAS**, the City of Opa-locka wants the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

**WHEREAS**, this proposed codesignation is located in County Commission District 1,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Approves the codesignation of Codadad Street from Jann Avenue to Ali-Baba Avenue in the City of Opa-locka as "The Honorable Brian Hooten Street".

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of Opa-locka, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the

Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

**Section 3.** All ordinances or Code provisions in conflict herewith are hereby repealed.






