





## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

## Background

A waiver for in-kind services has been requested by a not-for-profit organization the Juvenile Diabetes Research Foundation International, Inc. for their "JDRF International Walk" event scheduled for March 21, 2009.

In-kind services have been requested in an amount not to exceed \$32,050 from the Miami-Dade Park and Recreation Department for the Miami Metrozoo entrance fee waiver. This event will be funded from the countywide in-kind reserve fund.

In FY 2008-09, the Juvenile Diabetes Research Foundation International, Inc. has received no county funding for this event.
