RESOLUTION RESCINDING THE FY 2008-2009 ALLOCATION FROM THE GENERAL FUND IN THE AMOUNT OF \$40,000.00 TO FLORIDA ATLANTIC UNIVERSITY AND RE-ALLOCATING THOSE FUNDS TO THE UNIVERSITY OF WEST FLORIDA BOARD OF TRUSTEES, A PUBLIC BODY CORPORATE, FOR THE FLORIDA SMALL BUSINESS DEVELOPMENT CENTER NETWORK

WHEREAS, the Board previously allocated \$40,000 to the Florida Atlantic University for the Small Business Development Program; and

WHEREAS, Florida Atlantic University no longer offers the Small Business Development Program; and

WHEREAS, this Board desires to rescind the FY 2008-2009 allocation to Florida Atlantic University for the Small Business Development Program in the amount of \$40,000.00 from the General Fund; and

WHEREAS, this Board desires to re-allocate the amount of \$40,000.00 from the FY 2008-2009 General Fund to the University of West Florida Board of Trustees, a public body corporate, for the Florida Small Business Development Center Network to provide small business development seminars in Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:
