RESOLUTION APPROVING THE WAIVER OF PLAT OF MIAMI-DADE COUNTY PARKS AND RECREATION DEPARTMENT (DEERWOOD-BONITA LAKES PARK), D-22743, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 24, TOWNSHIP 55 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 144 STREET, ON THE EAST BY APPROXIMATELY SW 119 AVENUE, ON THE SOUTH BY APPROXIMATELY SW 152 STREET, AND ON THE WEST BY SW 122 AVENUE)

**WHEREAS**, Miami-Dade County, a political subdivision of the State of Florida, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southeast 1/4 of Section 24, Township 55 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


