



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MARCH 1, 2009 "2nd ANNUAL COMMUNITY FESTIVAL" SPONSORED BY THE CITY OF NORTH MIAMI BEACH IN AN AMOUNT NOT TO EXCEED \$2,566.00 TO BE FUNDED FROM THE DISTRICT 4 IN-KIND RESERVE FUND

WHEREAS, the City of North Miami Beach has requested in-kind services from the Miami-Dade Park and Recreation Department for the March 1, 2009 "2nd Annual Community Festival" in an amount not to exceed \$2,566.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "2nd Annual Community Festival" is a multi-cultural event which supports the growth of businesses and organizations in the area and features educational and recreational activities for children and adults; and

WHEREAS, the "2nd Annual Community Festival" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$2,566.00 of the in-kind services shall be funded from the District 4 In-kind Reserve Fund,

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services is being requested by the City of North Miami Beach for their "2nd Annual Community Festival" event scheduled for March 1, 2009.

In-kind services have been requested in an amount not to exceed \$2,566 from the Miami-Dade Park and Recreation Department for the use of a large show mobile. This event will be funded from District 4 in-kind reserve fund.

In FY 2008-09, the City of North Miami Beach has received \$16,000 from the General Fund and \$4,173 from District 4 discretionary reserve.
