RESOLUTION APPROVING THE CO-DESIGNATION OF PERVIS AVENUE FROM VETERANS WAY (ALI BABA AVENUE) TO ORIENTAL BOULEVARD (NW 151ST STREET) IN THE CITY OF OPA-LOCKA AS "THE HONORABLE BARACK OBAMA AVENUE"

WHEREAS, on December 10, 2008, the Opa-locka City Commission adopted Ordinance No. 08-28, which co-designated Pervis Avenue from Veterans Way (Ali-Baba Avenue) to Oriental Boulevard (NW 151st Street) as "Honorable Barack Obama Avenue" in recognition of President Barack Obama being elected on November 4, 2008 as the first African-American President of the United States; and

WHEREAS, President Obama has been an inspiration to many residents of the City of Opa-locka as well as many residents of Miami-Dade County; and

WHEREAS, Pervis Avenue from Veterans Way (Ali-Baba Avenue) to Oriental Boulevard (NW 151st Street) is a city road located in the City of Opa-locka; and

WHEREAS, the City of Opa-locka wants the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this proposed codesignation is located in County Commission District 1,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. Approves the co-designation of Pervis Avenue from Veterans Way (Ali-Baba Avenue) to Oriental Boulevard (NW 151st Street) in the City of Opa-locka as "The Honorable Barack Obama Avenue".

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor, Member of the City Commission and City Manager of the City of Opa-locka, the

United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:



ORDINANCE NO. 08-28

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF OPA-LOCKA, FLORIDA APPROVING THE DUAL DESIGNATION OF PERVIS AVENUE FROM VETERANS WAY (ALI-BABA AVENUE) TO ORIENTAL BOULEVARD (NW 151ST STREET) AS "THE HONORABLE BARACK OBAMA AVENUE"; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in recognition of the historic significance of President-Elect, Barack Obama, being elected on November 4, 2008 as the first African-American President of the United States; and

WHEREAS, President-Elect Obama has been an inspiration to so many residents of the City of Opa-locka; and

WHEREAS, it is proposed that Pervis Avenue from Veterans Way (Ali-Baba Ave.) to Oriental Blvd (NW 151st Street) in the City of Opa-locka ("City") be dual-designated as "The Honorable Barack Obama Avenue"; and

WHEREAS, in accordance with Chapter 19, Article III, Sections 19-28 and 19-29 of the Opa-locka Code of Ordinances, the Beautification, Environmental Control and Streetnaming Board has reviewed the proposed street name change and made a recommendation to the City Commission of the City of Opa-locka ("City Commission"); and

WHEREAS, the City Commission provided notice of a public hearing to be held on December 10, 2008, to consider the dual-designation of Pervis Avenue; and

WHEREAS, after hearing public comments on the matter, the City Commission has considered the recommendation to dual-designate Pervis Avenue from Veterans Way (Ali-Baba Ave.) to Oriental Blvd. (NW 151st Street) as "The Honorable Barack Obama Avenue".

THE COMMISSION OF THE CITY OF OPA-LOCKA HEREBY ORDAINS:

Section 1. The recitals to the preamble herein are incorporated by reference.


Section 2. The City Commission of the City of Opa-locka hereby approves the dual-designation of Pervis Avenue from Veterans Way (Ali-Baba Ave.) to Oriental Blvd. (NW 151st Street) as "The Honorable Barack Obama Avenue" and directs the City Manager to take all necessary actions to carry-out the intent and objectives of this Ordinance.

Section 3. All ordinances or Code provisions in conflict herewith are hereby repealed.

Section 4. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 5. This Ordinance shall, upon adoption, become effective as specified by the City of Opa-locka Code of Ordinances and the City of Opa-locka Charter.


