

RESOLUTION URGING COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO INSTRUCT PARK AND RECREATION DEPARTMENT, MIAMI-DADE AVIATION DEPARTMENT, MIAMI-DADE GOVERNMENT INFORMATION CENTER AND PORT OF MIAMI TO WORK WITH NEW WORLD OF SPORTS, INC. IN HOSTING THE NEW WORLD OF SPORTS-WORLD CHARITY SOCCER EVENT IN MIAMI-DADE COUNTY

WHEREAS, on June 8-15, 2009, the New World of Sports-World Charity Soccer Event will be take place in Miami-Dade County and approximately 75 world-renown, professional soccer players will attend this event; and

WHEREAS, the New World of Sports, Inc., in conjunction with these soccer players, will host a series of soccer clinics and the soccer players will play a friendly All-Star game between the European and Caribbean players; and

WHEREAS, Wagneau Eloi, Eric Abida, Rafael Marquez, and Guily Ludovic are some of the players that will be visiting Miami-Dade County for this event; and

WHEREAS, this Board finds that it is in the best interest of Miami-Dade County for this event to be successful,
