RESOLUTION CODESIGNATING S.W. 128th STREET BETWEEN S.W. 137th AVENUE AND S.W. 144th AVENUE AS "CAPTAIN EDUARDO B. FERRER STREET"

WHEREAS, Captain Eduardo B. Ferrer was a pilot, a Cuban-American patriot, a Miami Cuban Exile community activist, and a member of the 1961 Bay of Pigs Invasion of Cuba; and

WHEREAS, Captain Ferrer studied at his father's flying school in Havana at age 10, and flew solo at age 12; and

WHEREAS, Ferrer, a pilot for Cubana Airlines at 18, eventually rose to the rank of Captain; and

WHEREAS, upon arrival in the U.S., he returned to flying and became the first Cuban-American pilot for Eastern Airlines, eventually re-attaining the rank of Captain; and

WHEREAS, he retired after 25 years of service in 1986, and has remained active in retirement as an aviation consultant; and

WHEREAS, in 1960, Ferrer became an activist against the Communist Regime that took over in Cuba the previous year, participating in the underground resistance and eventually flying an aircraft out of Cuba; and

WHEREAS, Ferrer joined the "Liberation Air Force" of the Brigade 2506 in the failed Bay of Pigs Invasion of April 17, 1961; and

WHEREAS, Ferrer wrote for the press, was a frequent speaker on radio and television programs, authored several books, most notably Operation Puma: The Air Battle of the Bay of Pigs, a first hand account of the invasion as seen from the air; and

WHEREAS, he remained devoted to his wife, children and grandchildren until his passing in 2008, leaving a legacy of love, service and support for his family, friends, community and his adoptive country and his legacy endures; and

WHEREAS, this Board would like to honor the memory of Captain Eduardo B. Ferrer by codesignating S.W. 128th Street between S.W. 137th Avenue and S.W. 144th Avenue at its terminus within the Kendall-Tamiami Executive Airport as "Captain Eduardo B. Ferrer Street"; and

WHEREAS, S.W. 128th Street between S.W. 137th Avenue and S.W. 144th Avenue is a County road located in unincorporated Miami-Dade County and partially located within the Kendall-Tamiami Executive Airport; and

WHEREAS, this proposed codesignation is located in County Commission District 11,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Codesignates S.W. 128th Street between S.W. 137th Avenue and S.W. 144th Avenue at its terminus within the Kendall-Tamiami Executive Airport as "Captain Eduardo B. Ferrer Street."

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.
