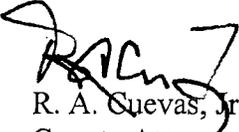

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE MAY 30, 2009 "2009 FAMILY EXPO" SPONSORED BY THE CHILDREN'S TRUST IN AN AMOUNT NOT TO EXCEED \$18,640.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT BUDGET

WHEREAS, the Children's Trust has requested in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the May 30, 2009 "2009 Family Expo" in an amount not to exceed \$18,640.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "2009 Family Expo" is to connect the public with key social and health services, as well as offer educational and cultural activities for the entire family; and

WHEREAS, the "2009 Family Expo" is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$16,000.00 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund and \$2,640.00 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the May 30, 2009 "2009 Family Expo" in an amount not to exceed

\$18,640.00 to be funded in part from the Countywide In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund.

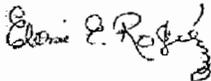

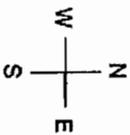

Subject: Countywide and Fire District Reserve In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The countywide and fire district in-kind reserve balances allow for funding of this request.

Background

A waiver for in-kind services has been requested by a not-for-profit organization, The Children's Trust, for the "2009 Family Expo" event scheduled for May 30, 2009.

In-kind services have been requested in an amount not to exceed \$16,000 from the Miami-Dade Police Department for personnel services and \$2,640 from the Miami-Dade Fire Rescue Department for personnel services for a total in-kind amount of \$18,640. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem in-kind reserve of the fire rescue district budget.

In FY 2008-09, The Children's Trust has received no county funding for this event.
