





Subject: District Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services is being requested by a not-for-profit organization, Florida Multi-Cultural Events Promotion, Inc., for their "Little Haiti Multicultural Summer Soccer Tournament" event scheduled for May 23, 2009.

In-kind services have been requested in an amount not to exceed \$2,666 from the Miami-Dade Park and Recreation Department for the use of a large show mobile. This event will be funded from District 3 in-kind reserve fund.

In FY 2008-09, Florida Multi-Cultural Events Promotion, Inc. has received no county funding for this event.
