



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MAY 1, 2009 “ES AHORA O NUNCA” SPONSORED BY THE HISPANIC COALITION, CORP., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,115.00 TO BE FUNDED FROM THE DISTRICT 5 IN-KIND RESERVE FUND

WHEREAS, the Hispanic Coalition, Corp. has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 1, 2009 “Es Ahora o Nunca” in an amount not to exceed \$1,115.00 (see attached Fee Waiver/In-kind Service Application); and



Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, the Hispanic Coalition, Corp., for their "Es Ahora o Nunca" event held on May 1, 2009.

In-kind services have been requested in an amount not to exceed \$1,115 from the Miami-Dade Park and Recreation Department for the use of a small show mobile. This event will be funded from the District 5 in-kind reserve fund.

In FY 2008-09, the Hispanic Coalition Corp. has received \$147,250 from the General Fund and \$25,000 from the following district discretionary reserve funds: \$5,000 from District 6, \$5,000 from District 7, \$5,000 from District 8, and \$10,000 from District 11.
