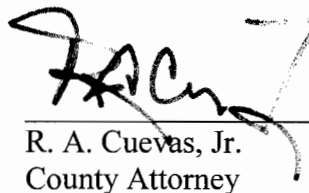

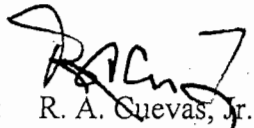

RESOLUTION REQUESTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO STUDY FEASIBILITY OF MIAMI-DADE TRANSIT DEPARTMENT OPERATING THE AUTOMATED PEOPLE MOVER THAT CONNECTS MIAMI INTERNATIONAL AIRPORT TO THE MIAMI INTERMODAL CENTER

**WHEREAS**, this Board has awarded a design-build-operate-maintain contract for the automated people mover facility that, when completed, will connect Miami International Airport to the Miami Intermodal Center, and that contract is currently in the design and construction phases under the administrative oversight of the Miami-Dade Aviation Department; and

**WHEREAS**, Miami-Dade Transit Department will be constructing and operating an extension of the Metrorail system that will connect with the Miami Intermodal Center; and

**WHEREAS**, the Miami-Dade Transit Department has long, extensive and successful experience operating and maintaining the automated people movers located in the business district of the City of Miami; and

**WHEREAS**, this Board is interested in learning whether it would be prudent and in the best interests of the citizens of Miami-Dade County for the Miami-Dade Transit Department to operate and maintain the automated people mover that will connect Miami International Airport to the Miami Intermodal Center,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board hereby requests that the County Mayor or his designee study the feasibility of assigning to the Miami-Dade Transit Department the task of operating and maintaining the automated people mover system and its associated vehicles that will connect Miami International Airport to the Miami

Intermodal Center. The County Mayor is requested to furnish this study to this Board within ~~[[30]]~~<sup>1</sup> >>60<< days of the effective date hereof.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan, and the Co-Sponsor is Commissioner Audrey M. Edmonson.
