

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MAY 16, 2009 "TROPICAL CORNUCOPIA" SPONSORED BY REDLAND TROPICAL GARDENS AND BOTANICAL FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,455.00 TO BE FUNDED FROM THE DISTRICT 8 IN-KIND RESERVE FUND

WHEREAS, the Redland Tropical Gardens and Botanical Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 16, 2009 "Tropical Cornucopia" in an amount not to exceed \$4,455.00 (see attached Fee Waiver/In-kind Service Application); and

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, Redland Tropical Gardens and Botanical Foundation, Inc., for their "Tropical Cornucopia" event held on May 16, 2009.

In-kind services have been requested in an amount not to exceed \$4,455 from the Miami-Dade Park and Recreation Department for the use of a small showmobile, generator, sound system and two (2) podiums. This event will be funded from the District 8 in-kind reserve fund.

In FY 2008-09, Redland Tropical Gardens and Botanical Foundation, Inc., has received no county funding for this event.
