RESOLUTION APPROVING THE WAIVER OF PLAT OF ST. ANDREW MISSIONARY BAPTIST CHURCH OF OPA LOCKA AND NEMO CREDIT CORP., D-23042, LOCATED IN THE NORTHEAST 1/4 OF SECTION 34, TOWNSHIP 52 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 119 STREET, ON THE EAST NW 17 AVENUE, ON THE SOUTH BY APPROXIMATELY NW 117 STREET, AND ON THE WEST BY APPROXIMATELY NW 18 AVENUE)

WHEREAS, St. Andrew Missionary Baptist Church of Opa Locka, a Florida non-for-profit corporation, and Nemo Credit Corp., a Florida corporation, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as Lots 12, 13, 14, 15, 16, 17, 18, 19, 20 and 21, Block 2, of "Revised Plat of Lake View Estates Unit 1", according to the plat thereof, as recorded in Plat Book 50, at Page 55, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 34, Township 52 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28 Subdivision of Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this

waiver of plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.




