RESOLUTION NO.	

RESOLUTION URGING THE FLORIDA LEGISLATURE TO CODESIGNATE N. KENDALL DRIVE/S.W. 88 STREET FROM S.W. 137<sup>TH</sup> AVENUE TO S.W. 142<sup>ND</sup> AVENUE AS "MANOLO CAPÓ BOULEVARD"; APPROVING SUCH CODESIGNATION

WHEREAS, Manuel "Manolo" Capó was a native of Pinar del Río, Cuba where his father, Simón, started a furniture store called Casa Capó in the 1930s; and

**WHEREAS**, up to 1959, Manolo Capó and the Capó family built Casa Capó into one of the three most important furniture outlets in Cuba; and

WHEREAS, Manolo Capó left Cuba in 1966 and seven months after arriving in the United States, Manolo Capó opened his own furniture store at Calle Ocho and 24th Avenue, named "El Dorado Furniture"; and

WHEREAS, Capó named El Dorado Furniture in honor of the small sailboat in which he and his children Luis and Carlos crossed the Straits of Florida fleeing the Castro regime; and

WHEREAS, Capó was later joined by his wife Aida to whom he was married for more than six decades, and Aida and Manuel had a total of seven children; and

WHEREAS, though a man of limited education, Capó built El Dorado Furniture to what it is today: a corporation with 11 stores in South Florida that employs over 1,000 employees with annual billings of \$150 million; and

WHEREAS, Capó was not only a savvy businessman, but also was active in the community, annually assisting Amigos for Kids, a children's aid organization, by making an El

Dorado Furniture warehouse available to Amigos for Kids so that every year, particularly at Christmas, toys could be collected for needy children; and

WHEREAS, Manolo Capó passed away on Friday, July 10 at the age of 83; and

**WHEREAS**, there is no better example of the success of the Cuban exile community than Manolo Capó and the business that he built in the U.S. from the ground up; and

WHEREAS, this Board would like to honor the memory of Capó by urging the Florida Legislature to codesignate N. Kendall Drive/S.W. 88 Street from S.W. 137<sup>th</sup> Avenue To S.W. 142<sup>nd</sup> Avenue as "Manolo Capó Boulevard"; and

**WHEREAS**, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

WHEREAS, before the Florida Department of Transportation will install signs reflecting the "Manolo Capó Boulevard" road codesignation, Miami-Dade County is required to pass a resolution in support of this road designation; and

**WHEREAS**, this state road designation would be located in District 11 if approved by the Legislature,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

<u>Section 1.</u> Urges the Florida Legislature to codesignate N. Kendall Drive/S.W. 88 Street from S.W. 137<sup>th</sup> Avenue to S.W. 142<sup>nd</sup> Avenue as "Manolo Capó Boulevard".

Section 2. Approves the codesignation of N. Kendall Drive/S.W. 88 Street from S.W. 137<sup>th</sup> Avenue to S.W. 142<sup>nd</sup> Avenue as "Manolo Capó Boulevard".

Section 3. Directs the Clerk of the Board to transmit certified copies of the resolution to the Governor; the Senate President; the House Speaker; the Chair and Members of the Miami-Dade State Legislative Delegation, and the Secretary of the Florida Department of Transportation.

Section 4. Directs the County's state lobbyists to advocate for the issues identified in Section 1 above, and directs that the 2010 state legislative package be amended to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Joe A. Martinez, and the Co-Sponsors are Vice-Chairman Jose "Pepe" Diaz and Commissioner Rebeca Sosa. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote,
