

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE GENERAL SERVICES ADMINISTRATION DEPARTMENT FOR THE AUGUST 1, 2009 "MIAMI ALL STARS BASKETBALL TOURNAMENT" SPONSORED BY THE MIAMI ALL STARS, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,200.00 TO BE FUNDED FROM THE DISTRICT 7 IN-KIND RESERVE FUND

WHEREAS, Miami All Stars, Inc. has requested in-kind services from the General Services Administration Department for the August 1, 2009 "Miami All Stars Basketball Tournament" in an amount not to exceed \$3,200.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Miami All Stars Basketball Tournament" is an event which gives stellar athletes an opportunity to participate in a basketball tournament; and

WHEREAS, Miami All Stars, Inc. is a not-for-profit organization; and

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, Miami All Stars, Inc., for their "All Star Basketball Tournament" event held on August 1, 2009.

In-kind services have been requested in an amount not to exceed \$3,200 from the General Services Administration Department for printing services. This event will be funded from the District 7 in-kind reserve fund.

In FY 2008-09, Miami All Stars Inc., received \$25,000 from the discretionary reserve fund from the following districts: \$5,000 from District 5, \$1,000 from District 7, \$5,000 from District 11, \$11,000 from District 12 and \$3,000 from District 13.
