RESOLUTION APPROVING THE CITY OF OPA-LOCKA'S
CO-DESIGNATION OF ALEXANDRIA DRIVE FROM NW
127TH STREET TO NW 135TH STREET AS "VANKARA
DRIVE"

WHEREAS, on September 5, 2007, the Opa-Locka City Commission adopted Resolution No. 07-7137 which designated Alexandria Drive from NW 127th Street to NW 135th Street as "Vankara Drive," in recognition of Vankara Christian School's contributions to the City of Opa-Locka, a copy of which is attached and incorporated by reference, and

WHEREAS, Alexandria Drive from NW 127th Street to NW 135th Street is a city street located in the City of Opa-Locka; and

WHEREAS, the City of Opa-Locka wants the County to install signage indicating this co-designation on County street signs and traffic signal masts arms; and

WHEREAS, this City of Opa-Locka co-designation is located in County Commission District 1,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Opa-Locka's co-designation of Alexandria Drive from NW 127th Street to NW 135th Street as "Vankara Drive."

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of Opa-Locka, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the

WHEREAS, Vankara Christian School has educated thousands of our youth, who have become outstanding professionals; and


WHEREAS, Vankara Christian School is an excellent educational facility which enhances our community.

Section 1. Resolution No. 06-7015 is hereby amended and the recitals to the preamble herein are incorporated by reference.




