RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE DECEMBER 18, 2009 "GREEN & GOLD FOOTBALL GAME" SPONSORED BY WEST MIAMI MIDDLE SCHOOL, IN AN AMOUNT NOT TO EXCEED \$1,597.50 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 6 FY 2008-09 IN-KIND RESERVE FUND

**WHEREAS**, West Miami Middle School, has requested in-kind services from the Miami-Dade Park and Recreation Department for the December 18, 2009 "Green and Gold Football Game" in an amount not to exceed \$1,597.50 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the traditional "Green and Gold Football Game" is attended by alumni, students, residents and community leaders; and

**WHEREAS**, the "Green and Gold Football Game" is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,597.50 of the in-kind services shall be funded from the unspent balance of the District 6 FY2008-09 In-kind Reserve Fund,



## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background
