RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 31, 2009 "COMMUNITY FALL FESTIVAL" SPONSORED BY NEW JERUSALEM PRIMITIVE BAPTIST CHURCH, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$820.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 2 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, New Jerusalem Primitive Baptist Church, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the October 31, 2009 "Community Fall Festival" in an amount not to exceed \$820.00 (see attached Fee Waiver/In-kind Service Application); and



Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, New Jerusalem Primitive Baptist Church, Inc., for their "Community Fall Festival" event held on October 31, 2009.

In-kind services have been requested in an amount not to exceed \$820 from the Miami-Dade Park and Recreation Department for the use of a 16' X 16' stage and two (2) light towers. This event will be funded from the unspent balance of the District 2 FY 2008-09 in-kind reserve fund.

In FY 2009-10, New Jerusalem Primitive Baptist Church, Inc., received no funding for this event.
