



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE FEBRUARY 26, 2010 "GARDEN SOIREE" SPONSORED BY THE COMMUNITY GARDEN CHARITABLE FUND, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,900.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 8 FY 2008-09 IN-KIND RESERVE FUND

**WHEREAS**, Community Garden Charitable Fund, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the February 26, 2010 "Garden Soiree" in an amount not to exceed \$2,900.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Garden Soiree" is to raise funds for the restoration of Pinecrest Gardens; and



## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Community Garden Charitable Fund, Inc., for their "Garden Soiree" event held on February 26, 2010.
