Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Inner City Community Development, Corp., for their "Christmas Lights on Broadway" event held on December 19, 2009.

In-kind services have been requested in an amount not to exceed \$790 from the Miami-Dade Park and Recreation Department for the use of a 24'X40' stage. This event will be funded from the unspent balance of the District 2 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Inner City Community Development, Corp., received \$21,250 from the General Fund to fund elderly services programs.
